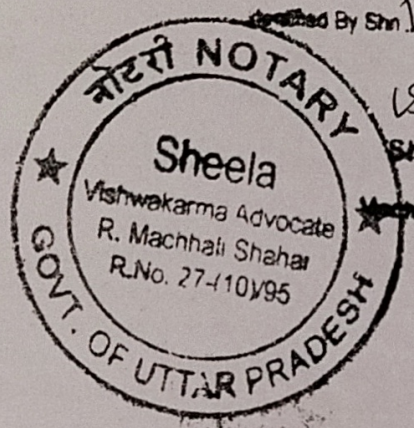

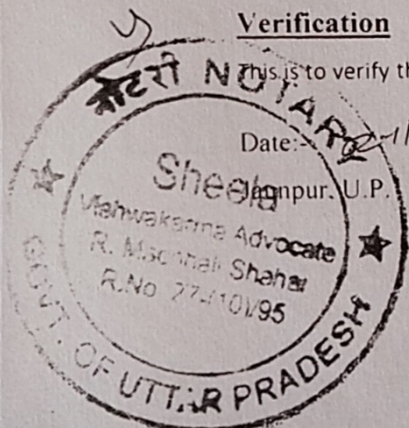
7. 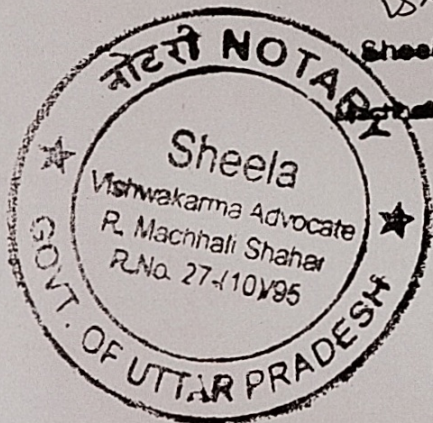
